New COVID Variant

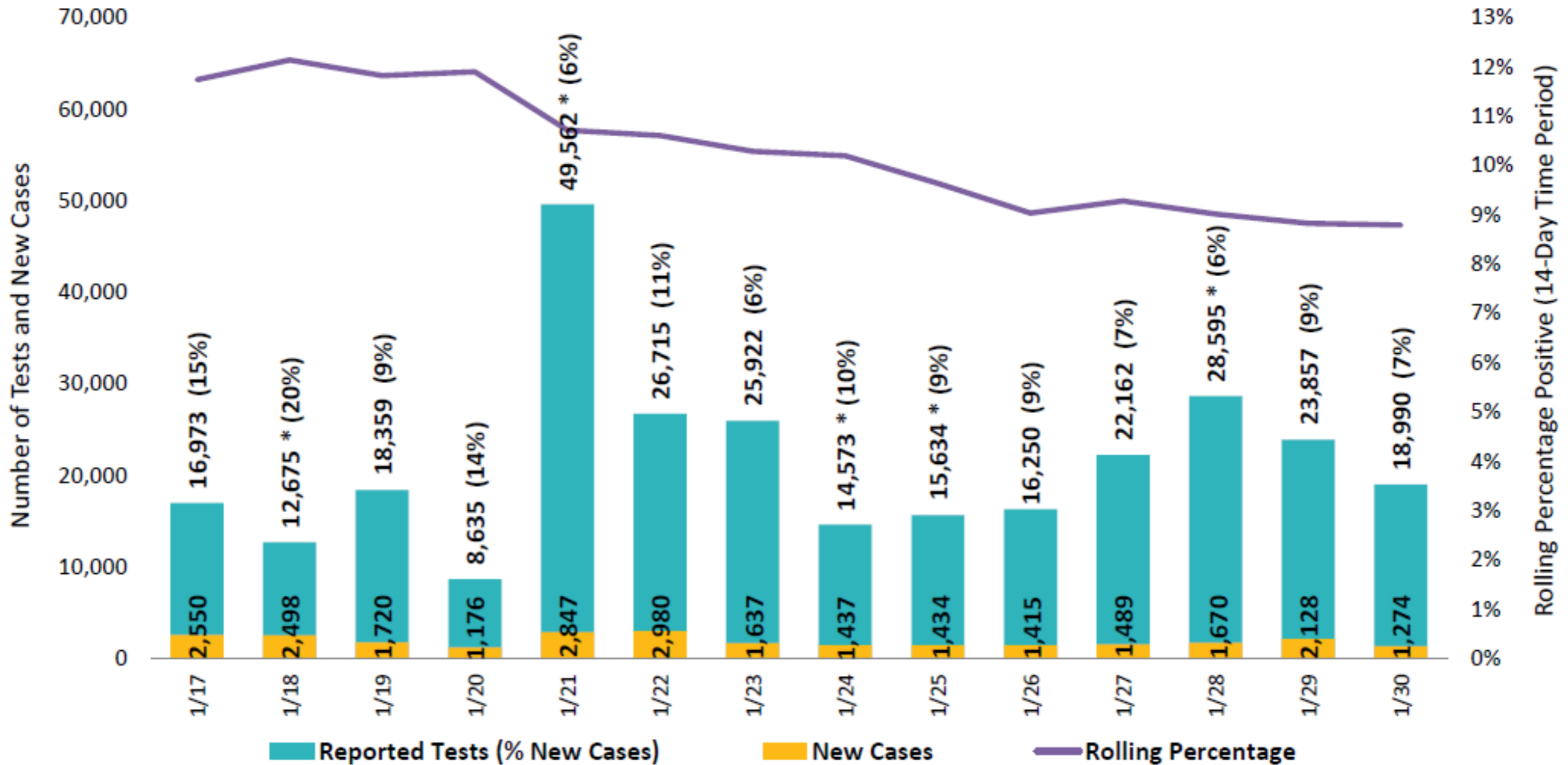
- 3 variants - U.K., South African, Brazil

Total Number of Cases = 238,042

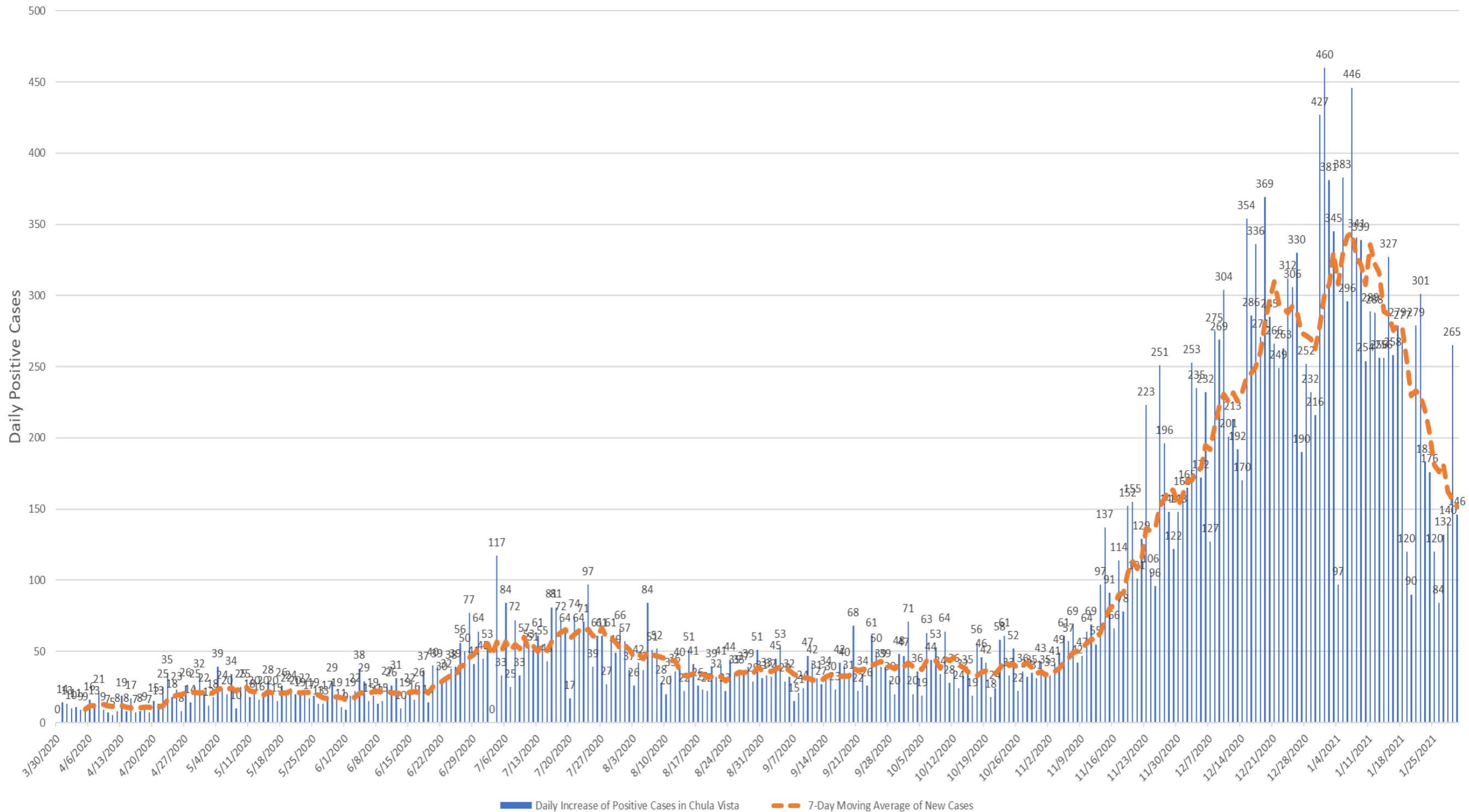

Daily New Cases in Chula Vista

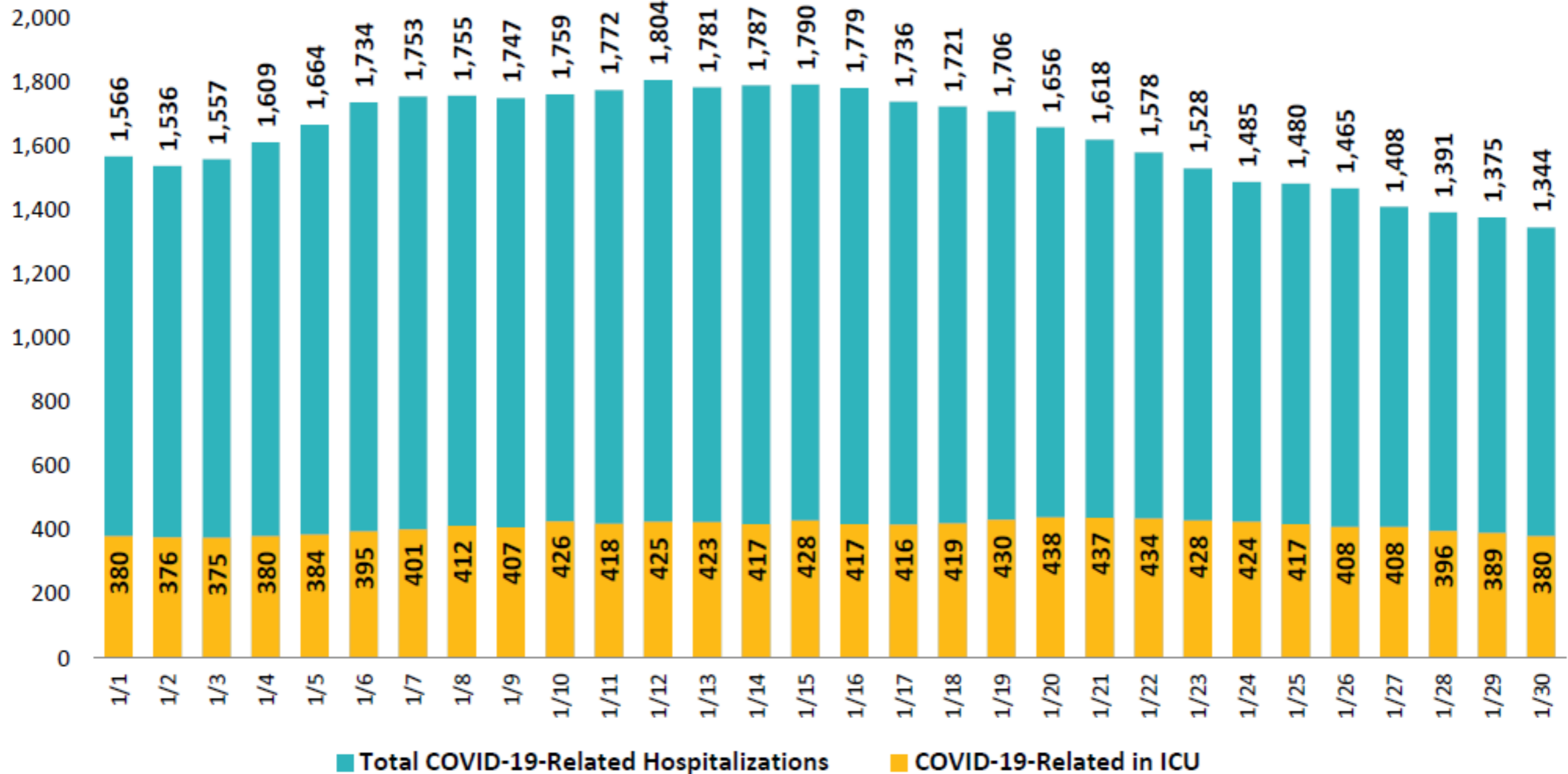
Daily Number of New Cases in Chula Vista / 7-Day Average of New Cases in Chula Vista

Regional Stay at Home Order

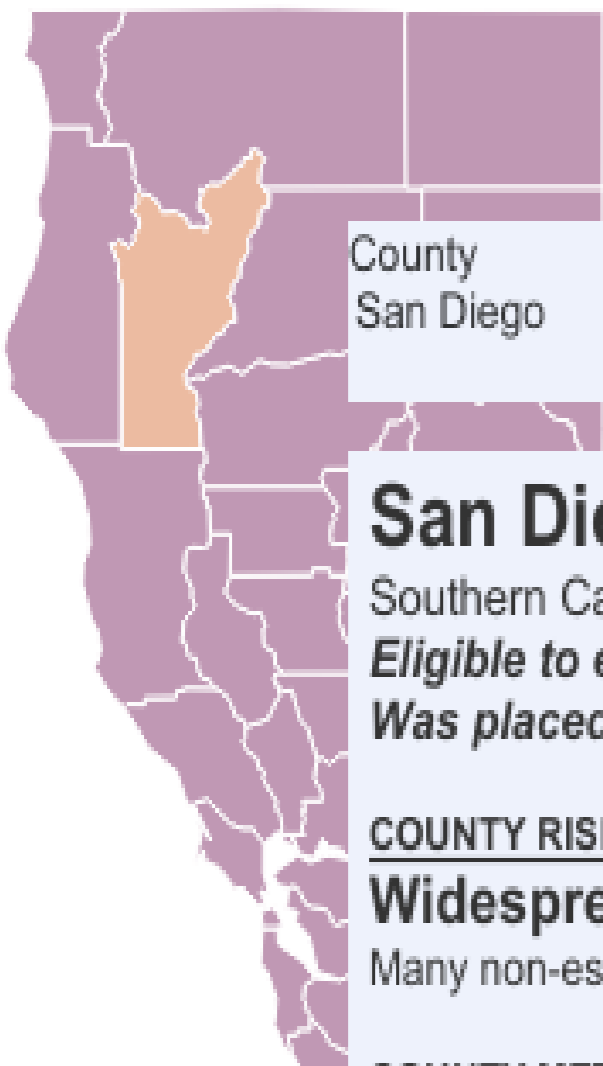
Last week we ended the Regional Stay at Home Order based on projected ICU capacity. Updated projections show improvement in much of the state.

Region	Projected ICU Capacity on 3/1
Southern California	43.7%
San Joaquin Valley	35.1%
Bay Area	33.3%
Greater Sacramento	31.4%
Northern California	29.2%

Projected capacity depends on 4 variables:

- Current estimated ICU capacity available
- Current community transmission
- Current regional case rates
- Proportion of cases admitted to the ICU

- Offering 900 appointments per day
 - Sunday-Thursday, 12:30-8pm
- Conducted 39,775 tests since October





Vaccination Superstation

- Mon – Fri, 10AM-7PM
 - 2,000 appointments/day
- Sat – Sun, 10AM-5PM
 - 1,500 appointments/day
- Appointments offered 3-4 in advance
- CV Library can help those 65+ schedule appointments
 - Available Mon-Fri 11AM-7PM
 - Call 619-476-2397



Mobile Vaccinations

- CVFD approved by State and County to conduct mobile vaccinations
- Target date of February 10
- All LTCF scheduled by CVS/Walgreens
- Working with the Housing Division to identify locations/facilities
 - Senior Affordable Housing
 - Mobile Home Housing
 - Senior Rental Housing

CDPH determines number of vaccine to local regions



County allocates vaccine based on available supply to COVIDReadi Enrollees*

Vaccination Phases

Vaccinating NOW*

Healthcare workers, others in Phase 1A (all Tiers), and those aged 65 and older may visit County vaccination sites, including the Petco Park Super Station.

Phase 1A-Tier 1 Vaccinating NOW*

- Acute care, psychiatric, and **correctional facility hospitals***
- Skilled nursing facilities, assisted living facilities, and similar settings for older or medically vulnerable individuals
 - Include residents in these settings as recommended for Phase 1A by ACIP
- Paramedics, EMTs, and others providing emergency medical services
- Dialysis centers
- Behavioral health residential facilities
- Vaccinators

Phase 1A-Tier 2 Vaccinating NOW*

- Intermediate care, for persons who need non-continuous nursing supervision, and supportive care
- Home healthcare and in-home supportive services
- Community health workers, including promotoras
- Public health field staff
- Primary care clinics, including Federally Qualified Health Centers, Rural Health Centers, correctional facility clinics, and urgent care clinics
- Behavioral health non-residential or outpatient facilities

Phase 1A-Tier 3 Vaccinating NOW*

Other settings and healthcare personnel not identified in Phase 1A-Tier 1 or Phase 1A-Tier 2, including:

- Specialty clinics, **laboratory workers****, dental/oral health clinics, pharmacy staff, and funeral workers and **others**.

Phase 1B Vaccinating NOW**

- 1B-Tier 1:
 - Persons aged 65 years and older

Phase 1B Vaccinating NEXT**

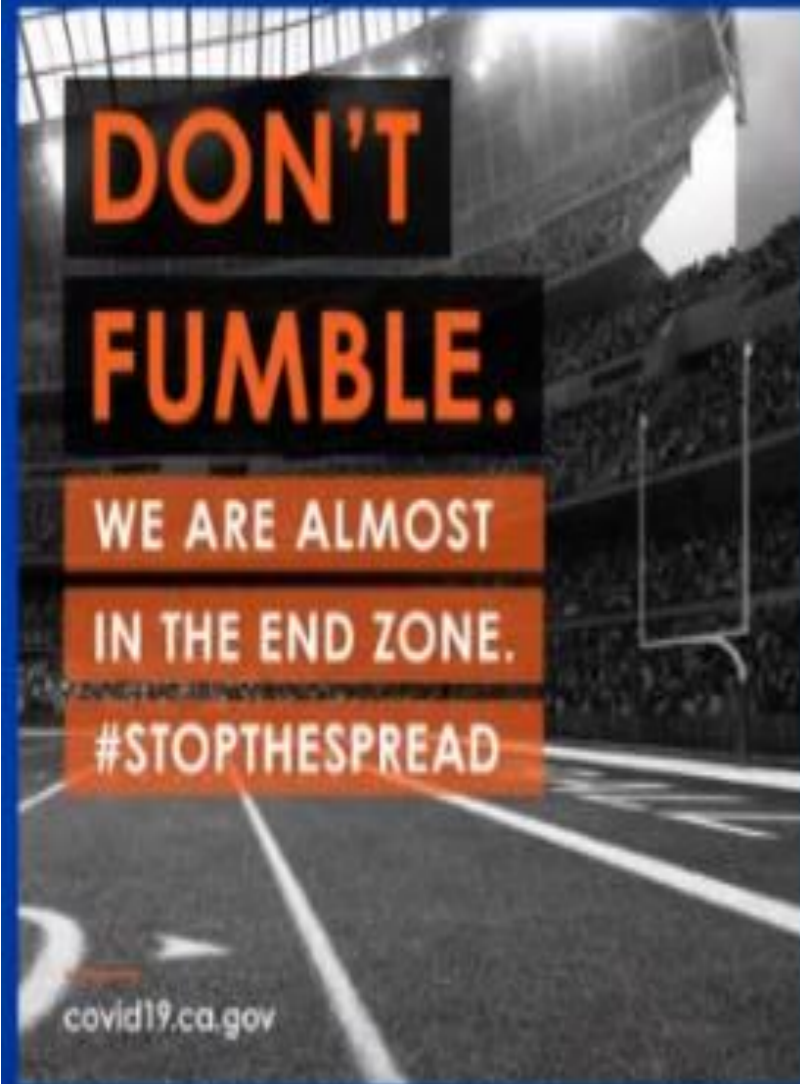
- 1B-Tier 1:
 - Those at risk of exposure at work in the following **sectors**: Education & Childcare; Emergency Services; and Food & Agriculture
- 1B-Tier 2:
 - Those at risk of exposure at work in the following **sectors**: Transportation Systems and logistics; Industrial, Commercial, Residential, and Sheltering Facilities and Services; Critical

Phase 1C**

- Persons 50-64 years of age
- Persons 16-49 years of age who have an underlying health condition or disability which increases their risk of severe COVID-19
- Those at risk of exposure at work in the following **sectors**: Water and Wastewater; Defense; Energy; Chemical and Hazardous Materials; Communications and IT; Financial Services; Government Operations/Community-based Essential Functions

Safer Super Bowl Tips

- After Thanksgiving, we saw a COVID surge that pushed our hospitals and ICUs to the brink. This was in part due to gatherings. We need to keep our guard up so this doesn't happen again
- We need to make sure Super Bowl celebrations don't turn into super spreader events
- Only celebrate or watch the game with your household
- Move it outdoors, wear a mask and stay 6 feet apart
