#### THIRD AMENDMENT TO ASSIGNMENT AGREEMENT

This Third Amendment to Assignment Agreement, dated as of June 1, 2016 (the "Third Amendment to Assignment Agreement"), is made and entered into by and between the Chula Vista Public Financing Authority, a joint powers authority duly organized and existing under the laws of the State of California (the "Authority"), as assignor, and U.S. Bank National Association, a national banking association organized and existing under the laws of the United States, as successor trustee to The Bank of New York Mellon Trust Company, N.A. and BNY Western Trust Company (the "Trustee"), and as assignee, and amends that certain Assignment Agreement between the Authority and the Trustee, dated as of September 1, 2004 and recorded in the official records of the County of San Diego (the "County") on September 15, 2004 as Document No. 2004-0877213, as previously amended by that certain First Amendment to Assignment Agreement dated as of March 1, 2006 and recorded in the official records of the County on March 15, 2006 as Document No. 2006-0177508 and that Second Amendment to Assignment Agreement dated as of September 1, 2015 and recorded in the official records of the County on September 2, 2015 as Document No. 2015-0464412 (collectively, the "Original Assignment Agreement");

### WITNESSETH:

WHEREAS, the Authority and the City of Chula Vista (the "City") have entered into a certain Site Lease, dated as of September 1, 2004, recorded on September 15, 2004 in the official records of the County as Document No. 2004-0877211, as amended by that certain First Amendment to Site Lease dated as of March 1, 2006, recorded on March 15, 2006 in the official records of the County as Document No. 2006-0177506, by that certain Second Amendment to Site Lease dated as of September 1, 2015, recorded on \_\_\_\_\_\_\_, 2015 in the official records of the County as Document No. 2015-\_\_\_\_\_\_, and by that certain Third Amendment to Site Lease, as recorded concurrently herewith (collectively, the "Site Lease"), whereby the City has leased to the Authority certain real property, including the improvements thereon, described in Exhibit A to Third Amendment to Site Lease and in Exhibit A hereto (the "Property"); and

WHEREAS, the Authority and the City have entered into a certain Lease/Purchase Agreement, dated as of September 1, 2004, recorded on September 15, 2004 in the official records of the County as Document No. 2004-0877212, as amended by that certain First Amendment to Lease/Purchase Agreement dated as of March 1, 2006, recorded on March 15, 2006 in the official records of the County as Document No. 2006-0177507, by that certain Second Amendment to Lease/Purchase Agreement dated as of September 1, 2015, recorded on September 2, 2015 in the official records of the County as Document No. 2015-0464411, and by that certain Third Amendment to Lease/Purchase Agreement, and recorded concurrently herewith (collectively, the "Lease"), whereby the Authority has leased to the City, and the City has leased from the Authority, the Leased Premises (as defined therein); and

WHEREAS, the Authority has assigned absolutely, without recourse, all of its rights to receive the Lease Payments scheduled to be paid by the City under and pursuant to the Lease to the Trustee and certain of its other rights, title and interest under the Lease, pursuant to the Original Assignment Agreement; and

WHEREAS, the Authority has assigned absolutely, without recourse, all of its rights to, under and pursuant to the Site Lease to the Trustee, pursuant to the Original Assignment Agreement; and

WHEREAS, the Authority and the Trustee desire to enter into this Third Amendment to Assignment Agreement in order to facilitate the execution and delivery of those certain \$\_\_\_\_\_ City of Chula Vista 2016 Refunding Certificates of Participation (Civic Center Project) (the "2016 Certificates"); and

WHEREAS, the 2016 Certificates are being executed and delivered as Additional Certificates under that certain Amended and Restated Trust Agreement, dated as of March 1, 2006, as amended by that First Supplement to Amended and Restated Trust Agreement, dated as of September 1, 2015 and by that Second Supplement to Amended and Restated Trust Agreement, dated as of June 1, 2016 (together, the "Trust Agreement"), each by and among the Trustee, the Authority and the City; and

NOW, THEREFORE, in consideration of the mutual covenants contained herein, and for other valuable consideration, it is hereby mutually agreed as follows:

- **SECTION 1.** <u>Definitions</u>. Unless the context otherwise requires, the capitalized terms used herein shall have the meanings specified in the Lease and the Trust Agreement.
- SECTION 2. <u>Execution and Delivery of 2016 Certificates</u>. From and after the date of the execution and delivery of the 2016 Certificates, the 2016 Certificates shall constitute Additional Certificates subject to the provisions of the Assignment Agreement.
- SECTION 3. <u>Rights of Successor Trustee</u>. In accordance with Section 9.01(e) of the Trust Agreement, U.S. Bank National Association has been appointed as successor trustee to The Bank of New York Mellon Trust Company, N.A. (the "Prior Trustee"), which was the successor-ininterest to BNY Western Trust Company, and, in accordance with the terms of the Trust Agreement, all right, title and interest of the Prior Trustee in and to the amounts pledged under the Trust Agreement and assigned to the Prior Trustee pursuant to the Original Assignment Agreement have vested in the Trustee, as successor to the Prior Trustee.
- **SECTION 4.** No Other Amendments. Except as expressly set forth in Sections 2 and 3 above, all other provisions of the Assignment Agreement remain in full force and effect.
- SECTION 5. <u>Counterparts</u>. This Third Amendment to Assignment Agreement may be executed in several counterparts, each of which shall be an original and all of which shall constitute but one and the same instrument.
