Councilmembers McCann and Miesen stated they would be abstaining from voting on Item 9 due to potential property-related conflicts of interest. They both left the dais at 5:45 p.m.

Landscape Architect Ferman and Principal Civil Engineer Rivera gave a presentation on the item.

Ron Hidinger, Chula Vista resident, spoke in support of staff's recommendation. He also expressed concern regarding the delay in expanding the corridor between Interstate 5 and Interstate 805.

Lisa Cohen, representing the Chula Vista Chamber of Commerce, spoke in support of staff's recommendation and thanked staff for meeting with the Chamber and the business owners on Main Street.

Marco Gonzalez, representing San Diego for Open Government, spoke regarding Closed Session Item 10 and expressed concern regarding related expenses to the City.

CITY MANAGER'S REPORTS

City Manager Halbert reported on his recent attendance at the Smart Cities Conference along with Economic Development Director Crockett. They gave a presentation on Smart City technologies for the Bayfront project. City Manager Halbert stated he would not be present at the October 6, 2015 Council meeting due to a ULI University of Development council meeting he would be attending. He stated Deputy City Manager Bacon would be leading the Olympic Training Center effort and working with the United States Olympic Committee.

MAYOR'S REPORTS

Mayor Salas expressed gratitude to Max and Leslie Branscomb and all other organizers of the Bonitafest event at Bonita Vista High School. She also congratulated South Bay Community Services on its recent Change Their Lives gala. Mayor Salas reported on her recent attendance at the 50th anniversary of the Vocal Music Department of Bonita Vista High School event. She announced the upcoming Beautify

Chula Vista event on October 10, 2015. Mayor Salas also stated there would be community meetings regarding the Olympic Training Center on September 24 and 28, 2015. She announced the Third Avenue Village Association's upcoming event, Semana De Los Muertos in recognition of Day of the Dead. Mayor Salas recognized Mexican Independence Day which occurred on September 16, 1810.

COUNCILMEMBERS' COMMENTS

Deputy Mayor Bensoussan announced the upcoming Hispanic Heritage Month celebration and the Ribbons & Shovels Awards event on October 22, 2015.

Councilmember Miesen spoke regarding the recent Coffee with a Councilmember event. He also announced that Economic Development Director Crockett would be hosting a Small Business Workshop on September 23, 2015, and he spoke of the Christmas in October and Beautify Chula Vista events which would be held on October 10, 2015.

Councilmember Aguilar commended City Manager Halbert on his presentation at the Smart Cities Conference, and stated Smart Cities would be discussed at the Third Thursday Breakfast in October. She recognized the success of the recent Harborfest and announced that the Starlight Parade would be held on December 5, 2015. Councilmember Aguilar also discussed the homelessness issue that was outlined in the Union Tribune August 26, 2015. The San Diego Regional Task Force conducted a count of homeless people and where they slept at night. There was consensus of the council to place an item on the October 13th agenda for discussion and possible direction to staff to begin to address issues related to homelessness.

Councilmember McCann expressed gratitude to all who attended Bonitafest and commended the Music Drama Department on its 50th anniversary. He congratulated Reina Bolles for being named Ms. Senior California and stated she would be participating in the Ms. United States Senior competition. He also spoke regarding the upcoming Beautify Chula Vista and Christmas in October, which would be held on October 10, 2015. He congratulated the owner of Auctions in Motion for the business's recent opening in Chula Vista.
