Chuck Schrader, Chula Vista resident, spoke regarding current city landscaping and spoke in opposition to removing landscaping and leaving bare dirt.

#### **CITY MANAGER'S REPORTS**

Deputy City Manager Bacon stated City Manager Halbert was attending the California American Planning Association Conference and would return the following week.

#### **MAYOR'S REPORTS**

Mayor Salas stated she had attended the Legislative Delegation in Washington D.C. last week. She also reported she and Councilmember Miesen participated in the California League of Cities meeting. Mayor Salas spoke of supporting the Chula Vista Firefighters in fighting breast cancer by wearing pink on October 8, 2015. She also stated a freshman of Chula Vista High School, Giancarlo Gil, had contracted a flesh-eating bacteria and had his right leg amputated, she mentioned a "Go Fund Me" account had be established to raise money for his surgeries. Mayor Salas congratulated Assistant City Clerk Bigelow for being named "Assistant City Clerk of the Year" by the Southern California City Clerk's Association.

# **COUNCILMEMBERS' COMMENTS**

Councilmember Miesen commented on the California League of Cities meeting. He also mentioned that Beautify Chula Vista and Christmas in October would be held October 10, 2015.

Deputy Mayor Bensoussan reported on the 25th Annual South County Economic Summit, and mentioned there was still sponsorship opportunities available for the Ribbon and Shovels event October 22, 2015. Deputy Mayor Bensoussan stated there would be a Dog Costume Party Contest "Howl-A-Ween" event benefiting the Animal Care Facility at Savoie Restaurant in Otay Ranch Town Centre on October 28, 2015. She also announced that the Norman Park Senior Center deferred maintenance efforts would take place in February or March 2016.

Councilmember McCann announced he had attended a ribbon cutting ceremony for U.S. Karate Academy in Rolling Hills, and presented Mayor Salas with a Black Belt from the Academy. Councilmember McCann commended Environmental Services Manager France and her team for all their efforts with Beautify Chula Vista and mentioned the upcoming Christmas in October event. He expressed concern regarding the purchase of three grocery stores in Chula Vista by Haggen and that they would be closing. Councilmember McCann mentioned October being Breast Cancer Awareness month and that the Relay for Life event would be held June 25, 2016 at Hillcrest Elementary School.

City Attorney Googins announced that the Council would convene in closed session to discuss the items listed below. He recommended that Councilmember Miesen recuse himself from Item 8. Councilmember Miesen stated he would abstain from participating in discussion and voting on that item.
