

## Third Amendment to the Granicus Service Agreement between Granicus, Inc. and Chula Vista, CA

This Third Amendment to the Granicus, Inc. Service Agreement is effective on the date this document is signed and entered into by and between Granicus, Inc., a California Corporation (hereinafter referred to as "Granicus"), and Chula Vista, CA (hereinafter referred to as "Client"), with reference to the following:

WHEREAS, the Client and Granicus entered into an Agreement effective 4/2/2017 (the "Agreement"); and

NOW, THEREFORE, in consideration of the premises, the parties intend that the Agreement be amended as follows:

1. The parties wish to extend the Agreement through 6/30/2021 as detailed in Exhibit A. Exhibit A is exclusive of applicable state, local, and federal taxes, which, if any, will be included in the invoice. It is the responsibility of the Client to provide applicable exemption certificate(s).
2. Client has the option to extend this Agreement for one additional one-year terms. If the Client exercises an option to extend, each extension shall be on the same terms and conditions contained in this Agreement, provided that the amounts specified in Exhibit A may be increased by up to 5% for each extension. The Client shall give written notice to Granicus of the Client's exercise of its option to extend at least 30 days prior to the expiration of the term.
3. Except as amended by this Third Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
4. In the event of any inconsistency between the provisions of this Third Amendment and the documents comprising the Agreement, the provisions of this Third Amendment shall prevail.

IN WITNESS WHEREOF, the parties have caused this Third Amendment to be executed by their duly authorized representatives.
