DATE OF FINAL PASSAGE APR 11 2019

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING A CONTRACT FOR FUEL
WITH SC COMMERCIAL (d/b/a THE SOCO GROUP)
IN THE AMOUNT NOT TO EXCEED \$87,475,196.

WHEREAS, the City issued Request for Proposals No. 10089315-18-K for various fuels as a cooperative procurement with other local public agencies, in an effort to obtain better prices through economy of scale; and

WHEREAS, this item will execute and award a contract for as-needed fuel with SC Commercial, LLC (d/b/a The SoCo Group) in an amount not to exceed \$87,475,196 over the five-year term of the contract (Agreement); and


WHEREAS, this Agreement will provide the City with operationally-critical fuel types including unleaded gasoline, renewable diesel, ultra-low sulfur diesel, and biodiesel, products used by the City on a daily basis; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, a five-year contract with SC Commercial, LLC (d/b/a The SoCo Group) to provide fuel in an amount not to exceed \$87,475,196 under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR - 312290.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend funds in an amount not to exceed \$87,475,196 over the term of the Agreement for as-needed fuel, contingent upon the approval of the annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing one or more

certificates certifying that funds necessary for expenditures are, or will be, on deposit with the City Treasury.
