TITLE

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA RECITING THE FACT OF THE SPECIAL MUNICIPAL ELECTION HELD IN THIS CITY ON NOVEMBER 3, 2020, DECLARING THE RESULTS THEREOF, AND OTHER MATTERS AS ARE PROVIDED BY LAW

RECOMMENDED ACTION

Council adopt the resolution.

SUMMARY

The Registrar of Voters has transmitted the certified results of the Special Municipal Election held on November 3, 2020. Elections Code Section 10262(b) requires the City Clerk, as the City elections official, to certify the results of the election to the City Council, which shall adopt a resolution reciting the fact of the election.

DISCUSSION

A special municipal election was held on November 3, 2020 to elect two members of the City Council to represent Districts 3 and 4, each for a full term, which will commence upon taking the oath of office.

Elections Code Section 10262(b) requires the City Clerk, as the City elections official, to certify the results of the election to the City Council, which shall adopt a resolution reciting the fact of the election. Certified results of the election are attached as Exhibit 1.
