RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA ACCEPTING BIDS AND AWARDING CONTRACT FOR THE "LED MESSAGE BOARDS AT THE CHULA VISTA POLICE DEPARTMENT" PROJECT TO SIGNTECH ELECTRICAL ADVERTISING, INC. IN THE AMOUNT OF \$143,761 AND APPROPRIATING AN ADDITIONAL \$19,574 FROM THE AVAILABLE BALANCE OF THE ASSET SEIZURE FUNDS THEREFORE (4/5 VOTE REQUIRED)

WHEREAS, Police Department has worked with the Public Works Department on adding two LED message displays on the corner of 4th and F Street and to replace two of the current static displays with Police Badges; and

WHEREAS, the prominent highly visible location of the LED displays on the north-west corner of the Police Department property will enhance the Department's ability to effectively communicate with the public; and

WHEREAS, on October 14, 2015 the Director of Public Works received one (1) sealed bid for the "LED Message Boards at the Chula Vista Police Department" project; and

WHEREAS, the following bid was received:

WHEREAS, staff reviewed the bid and determined the bid submitted by Signtech Electrical Advertising, Inc. was below the Engineer's estimate of \$175,00 by \$31,239 or 17.9%; and

WHEREAS, Signtech Electrical Advertising, Inc. is currently licensed Class C-45 Electrical Signs Contractor (License No. 457406); and

WHEREAS, staff contacted referenced provided by Signtech Electrical Advertising, Inc. and determined that they have the relevant experience necessary to complete this project as defined in the specifications; and

WHEREAS, all companies associated with this contract are registered as a public works contractors with the California Department of Industrial Relations (DIR); and

WHEREAS, in accordance with the provisions of Section 1773 of the Labor code of the State of California, the contractor and its subcontractor are required by bid specifications to pay prevailing wages to persons employed by them for work under this contract; and

WHEREAS, an appropriation of \$19,574 from the available balance of the Asset Seizure fund is recommended to provide sufficient funds for construction costs associated with this project.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chula Vista, that it does hereby accept bids; award a contract for the "LED Message Boards at the Chula Vista Police Department" project to Signtech Electrical Advertising, Inc. in the amount of \$143,761; and appropriate \$19,574 to the Supplies and Services expenditure category of the Asset Seizure Fund.
