RE: Terms for Extension of that certain Revised and Restated Agreement for Basic and Advanced Life Support Ambulance Services Agreement, dated effective July 1, 2011, between the City of Chula Vista, Imperial Beach Fire Department and Bonita/Sunnyside Fire Protection District (collectively, the "EOA Agencies") and American Medical Response Ambulance Service, Inc. f/k/a Laidlaw Medical Transportation, Inc., a Delaware corporation, dba American Medical Response ("AMR"), as amended by that certain First Amendment to the Revised and Restated Agreement for Basic and Advanced Life Support Ambulance Services, dated effective October 1, 2014, and that certain Second Amendment to the Revised and Restated Agreement for Basic and Advanced Life Support Ambulance Services, dated effective October 1, 2016 ("Second Amendment"), as recently extended by the City Manager pursuant to the terms of the Second Amendment until March 31, 2018 (collectively, the "EOA Agreement").

Dear AMR:

This letter supersedes my previous letter dated March 21, 2018.

As you know, the EOA Agreement between the EOA Agencies and AMR is due to expire on March 31, 2018. As you also know, the parties so far have been unable to reach mutually acceptable terms for the extension of this agreement. To provide additional time to negotiate such terms, or, if mutually agreeable terms for such an extension cannot be reached, to provide all parties a reasonable opportunity for the orderly transition to an alternative emergency ambulance services provider, the EOA Agencies propose the following amendment to the EOA Agreement, and any local agency administrative agreements between the parties entered into in connection therewith (collectively, the "Administrative Agreements"):

1. The term of the EOA Agreement, and any Administrative Agreements, shall be extended until May 31, 2018 on their existing terms and conditions. The parties will negotiate in good faith during this time period for longer term extensions of the EOA Agreement and any Administrative Agreements.

2. If agreements for further extensions are not reached during this time-period, the EOA Agreement and any Administrative Agreements will continue on their same terms and conditions until August 31, 2018, at 11:59 p.m. at which point they shall automatically terminate.
3. Except as amended hereby, all other terms and conditions of the EOA Agreement and any related Administrative Agreements shall remain in effect.

I am submitting this proposal to you in my capacity as the contract administrator for the EOA Agreement with the express prior approval of all EOA Agencies. If this proposal is acceptable to AMR, please cause it to be signed where indicated below by an authorized AMR representative and transmit back to me by no later than 4:00 p.m. on Friday, March 23, 2018. This will allow me to place it on the March 27th agenda for City Council consideration. This proposal remains subject to City Council approval.
