## RESOLUTION NO. 2014\_\_\_\_

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA RECITING THE FACT OF THE SPECIAL MUNICIPAL ELECTION HELD IN THIS CITY ON NOVEMBER 4, 2014, DECLARING THE RESULTS THEREOF, AND SUCH OTHER MATTERS AS ARE PROVIDED BY LAW

WHEREAS, a special municipal election was held and conducted in the City of Chula Vista, on Tuesday, November 4, 2014, for the purpose of electing a mayor, a city attorney, and two (2) members of the City Council (Seats 1 and 2), each for a full term of four years, and for submitting two ballot measures (Propositions A and B) to the electorate; and

WHEREAS, notice of said election was duly and regularly given in the time, form, and manner as provided by law; and in all respects said election was held and conducted, and the votes cast at the election received and canvassed, and the returns made and declared, in the time, form, and manner required by the California Elections Code and the City Charter; and

WHEREAS, pursuant to Resolution No. 2014-120 adopted July 8, 2014, and Resolution No. 2012-158 adopted August 5, 2014, the election was consolidated with the statewide general election, and the Registrar of Voters canvassed the returns of said election and has certified the results. The results have been received and are attached as Exhibit A to this Resolution.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chula Vista as follows:

- SECTION 1. There were 122 voting precincts established for the purpose of holding a special municipal election on November 4, 2014, consisting of the regular election precincts in Chula Vista as established for the holding of state and county elections.
- SECTION 2. The number of votes cast at the polling places was 14,164 and the number of vote-by-mail ballots cast was 25,838, making the whole number of votes cast in the City 40,002.
- SECTION 3. The names of the nominees for Mayor were Mary Salas and Jerry R. Rindone.
- SECTION 4. The City Council does hereby declare Mary Salas as elected to the office of Mayor, to be sworn into office on December 9, 2014.
- SECTION 5. The names of the nominees for Seat 1 were John McCann and Steve Padilla.
- SECTION 6. The City Council does hereby declare John McCann as elected to the office of City Council, Seat 1, to be sworn into office on December 9, 2014.

- SECTION 7. The names of the nominees for City Council, Seat 2 were Patricia Aguilar and Dan Smith.
- SECTION 8. The City Council does hereby declare Patricia Aguilar as elected to the office of City Council, Seat 2, to be sworn into office on December 9, 2014.
- SECTION 9. The name of the nominee for City Attorney was Glen Googins, who was unopposed.
- SECTION 10. The City Council does hereby declare Glen Googins as elected to the office of City Attorney, to be sworn into office on December 9, 2014.
- SECTION 11. The City Council does hereby declare that a majority of voters who voted on Proposition A, a City Charter amendment related to public works and general purchasing procedures, voted in favor of it, and that the measure passed.
- SECTION 12. The City Council does hereby declare that a majority of voters who voted on Proposition B, a City Charter amendment related to filling a City Council vacancy, voted in favor of it, and that the measure passed.
- SECTION 13. The number of votes given at each precinct and the number of votes given in the City to the candidates named above for the offices for which they were candidates, and for and against Propositions A and B, are listed in Exhibit A, attached to this Resolution and incorporated by this reference.
- SECTION 14. The City Clerk shall enter on the records of the City Council of the City of Chula Vista a statement of the results of the election, showing the whole number of votes cast in the City, the names of the persons voted for, what office each person was voted for, and the number of votes given in the City to each person, and for and against Propositions A and B.
