The YSC President's Committee discussed that adding new organizations into the YSC would not be possible at this time because of the lack of space. A round table discussion was had. Albion Soccer Club, a visitor to the meeting asked if this was due to Albion being in Chula Vista, and Victor spoke to him and said that any organization would be in the same situation, that it had nothing to do with Albion. Round table discussion continued. A vote was taken. All voting members approved the MOU. None disagreed.

Treasurer's Report - No updates at this time but did give Tim check to deposit.

The Field Management report was discussed. The new sections on the field management report were shown. The new sections are the parts that show who has what allocation and what maintenance was done.
