

B. The City Council shall set forth by resolution the officials, designated employees, and consultants who are required to file statements of economic interests and the disclosure categories under which each such official, designated employee and consultant shall file. By this reference, the resolution, and any amendments to it, is incorporated into this conflict of interest code. The City's disclosure categories are set forth below (please refer to the definitions within this Chapter and the PRA for capitalized terms in bold type):

~~1. All investments;~~ Disclosure Category 1: Report all of the following:

a. **Investments** in, and business positions ~~in business entities~~ held with, any **Business entity** located ~~in,~~ or doing business within the City's ~~jurisdiction~~ **Jurisdiction**, or doing business with the City; and ~~all sources of income (including gifts, loans, and travel payments);~~

b. **Income** from any source, regardless of the jurisdiction in which the source resides or does business.

Disclosure Category 2: ~~All interests: Report any Interest in real property for such real property that is located within the jurisdiction~~ **Jurisdiction** of the City;

~~3. All investments,~~

Disclosure Category 3: Report all of the following:

a. **Investments** in, and positions ~~in business entities, interests in real property, and income (including gifts, loans, and travel payments) from sources that are~~ held with, any **Business entity**, that is subject to the regulatory, permitting, or licensing authority of the ~~designated employee's~~ City department; in which you work ("Departmental Authority"); and

~~4. All investments;~~ b. **Interests in real property** if the real property is subject to such Departmental Authority; and

c. **Income** from any source which is subject to such Departmental Authority.

Disclosure Category 4: Report all of the following:

a. **Investments** in, and business positions ~~in business entities, and all income (including gifts, loans, and travel payments) from sources that engage~~ held with, any **Business entity** that engages in land development, construction, or the acquisition or sale of real property, within the ~~jurisdiction~~ **Jurisdiction** of the City; and

b. **Income** from any source that that engages in land development, construction, or the acquisition or sale of real property, within the **Jurisdiction** of the City.

Disclosure Category 5: ~~All investments and positions in business entities and income (including gifts, loans and travel payments):~~ Report all of the following:

a. **Income** from sources that provide leased facilities, goods, equipment, vehicles, machinery, or services, (including training or consulting services), of the type utilized by the City; (“City Goods and Services”); and

~~6. All investments~~b. **Investments** in, and business positions held with, any **Business entity** which provides such City Goods and positions in business entities and income (including gifts, loans and travel payments) from sources that provide Services.

Disclosure Category 6: Report all of the following:

a. **Income** from any source that provides leased facilities, goods, equipment, vehicles, machinery, or services, (including training or consulting services), of the type utilized by the designated employee’s City department; in which you work (“Departmental Goods and Services”); and

b. **Investments** in, and business positions held with, any **Business entity** which provides such Departmental Goods and Services.

Disclosure Category 7. ~~All investments, positions in:~~ Report all of the following:

a. **Income** from any source that is of the type that receives grants or other monies from or through the City; and

b. **Investments** in, and business entities, income (including gifts, loans and travel payments), and income from non-profit positions held with, any **Business entity**, including non-profit organizations, ~~if the source that~~ is of the type that receives grants or other monies from or through the City.
