City Manager Halbert stated he spoke at a recent Smart Cities conference. He also spoke regarding his recent visits to universities and the opportunities he had to discuss the City's university project.

MAYOR'S REPORTS

Mayor Casillas Salas spoke regarding her attendance a recent conference, Shaping the Transformation of Urban Mobility, sponsored by the World Economic Forum. She stated that SDG&E announced it would install electric vehicle charging stations in the City. Mayor Casillas Salas spoke regarding the recent, positive media reports on the City.

COUNCILMEMBERS' COMMENTS

Deputy Mayor Miesen spoke regarding the recent South Bay Family YMCA grand reopening event.

Councilmember Aguilar stated she had received complaints regarding issues related to parking. She spoke regarding impacts on the east side between multi-family and single-family neighborhoods, and on the west side with the elimination of parking spaces with the addition of bike lanes.

At the request of Councilmember Aguilar, there was consensus of a majority of the Council to direct staff to review the City's ordinances for improvements to parking availability to alleviate some of the parking-related impacts on residents.

At the request of Councilmember Aguilar there was consensus of the Council to add item to the agenda of April 12, 2016, to discuss the formation of an ad-hoc subcommittee for the purposes of planning the 2016 Starlight Parade.

Councilmember McCann spoke regarding Easter events in the City, the opening of the Smart and Final in the Terra Nova Plaza, the recent intergenerational games.

City Attorney Googins announced that the Council would convene in closed session to discuss the items listed below.

Mayor Casillas Salas recessed the meeting at 5:42 p.m. The Council reconvened in Closed Session at 5:45 p.m., with Councilmembers Aguilar, McCann, Miesen, and Mayor Casillas Salas present.
