RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHULA VISTA ACCEPTING BIDS, WAIVING A MINOR BID IRREGULARITY, AND AWARDING A CONTRACT FOR THE "PAVEMENT MINOR REHABILITATION FY15/16 (STL409)" PROJECT TO PAL GENERAL ENGINEERING, INC. IN THE AMOUNT OF \$1,179,402.35 AND APPROPRIATING \$29,755 FROM THE AVAILABLE BALANCE OF THE TRANSPORTATION PARTNERSHIP FUND TO STL409

WHEREAS, City staff prepared specifications for the "Pavement Minor Rehabilitation FY15/16 (STL409)" project and advertised the project on July 29, 2016; and

WHEREAS, on August 24, 2016, the Director of Public Works Engineering received four (4) sealed bids for the "Pavement Minor Rehabilitation FY15/16 (STL409)" project as follows:

^{*}The submitted bid proposal contained a minor irregularity that did not affect the bid amount. Corrections of bid totals did not change the outcome and ranking of the bids.

WHEREAS, the lowest bid contained an irregularity, in that a signed copy of addendum 2 was not incorporated into the bid submittal; and

WHEREAS, though the addendum was not included, staff determined that this irregularity was minor, as the bidder acknowledged its understanding of the changes required by the addendum by incorporating all such changes into its bid; and

WHEREAS, Staff's review of the apparent low bid submitted by PAL General Engineering, Inc. and its minor irregularity did not change the bid amount or ranking order of the bids; and

WHEREAS, the low bid submitted by PAL General Engineering, Inc. is above the Engineer's estimate of \$1,172,640.76 by \$6,761.59 (or approximately 0.58% above the Engineer's estimate); and

WHEREAS, the total "Pavement Minor Rehabilitation FY15/16 (STL409)" project is anticipated to cost \$1,329,928 including \$129,736.65 for contingencies, staff time, material testing and other costs; and

WHEREAS, PAL General Engineering, Inc. is a currently active licensed Class A General Engineering Contractor (License No. 916931), and staff has verified the references and the work performed by the contractor on previous City projects and has found their work to be satisfactory; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chula Vista, that it does hereby accept bids and award a contract for the "Pavement Minor Rehabilitation FY15/16 (STL409)" project to PAL General Engineering, Inc. in the amount of \$1,179,402.35.

BE IT FURTHER RESOLVED by the City Council of the City of Chula Vista, that it does hereby appropriate \$29,755 from the available balance of the Transportation Partnership Fund to CIP STL409, "Pavement Minor Rehabilitation FY15/16."
