RE:

University of Saint Katherine Exclusive Right to Negotiate

On January 23, 2018, the City Council approved entering into an Exclusive Negotiating Agreement with the University of Saint Katherine (USK) which allowed staff the opportunity to conduct due diligence on USK in a phased approach. The Initial Term of the ENA was for ninety (90) days with an ability to extend for up to two (2) additional ninety (90) day periods. The first phase of the Exclusive Negotiating Agreement (ENA) with the University of Saint Katherine (USK) was to report on the institution's academic record and rigor of its programs and students. Our review is complete and based on our findings we recommend extending the ENA for an additional ninety (90) days to evaluate their financial capabilities to build, maintain and operate a new facility on the University and Innovation District property. The following is a report of our findings that support our recommendation to extend.

#### **Background:**

USK is a private, non-profit California public benefit corporation located in San Marcos, California. The University began instruction in September 2011 and was accredited by the Western Association of Schools and Colleges and University Commission (WASCUC) in February 2016. USK currently enrolls approximately 200 Full Time Equivalent (FTE) students. USK offers both Bachelor of Arts (BA) and Bachelor of Science (BS) degree programs. BA programs include Art, Business Management, History, Literature, Interdisciplinary Studies, Music, and Orthodox Christian Theology, while BS programs include Biochemistry & Chemistry, Biological Sciences, and Kinesiology. USK is an independent, Orthodox Christian institution of higher education.

#### Academic Rigor:

USK academic rigor is supported in two ways. The first is USK accreditation by WASCUC and maintaining their good standing with WASCUC. The second is USK and their articulation agreements with other institutions of higher education. Articulation Agreements are generally developed for specialized professional or technical programs offered at colleges that can be applied to a specific four-year program/major at the receiving university. USK maintains articulation agreements for teaching credential instruction (K-12) with the University of San Diego; Master in Science for Kinesiology with Point Loma Nazarene University; and medical,

dental and pharmacy school with the Lake Erie College of Osteopathic Medicine. Additional degree programs are also in development to offer a Bachelor's in Science for Psychology and Master of Arts in Leadership. USK is also working on a strong collaborative partnership with Southwestern Community College including completing a transfer agreement. Successful market entry in South County will be enhanced by articulation and other collaborative agreements between the two institutions. Both share a student-centered education orientation and have demonstrated service to local communities. Shared faculty and co-development of academic programs will enhance the educational strength of both institutions.

#### Academic Record:

The 4-year graduation rate at USK is over 70% with a target rate of 90%. It is important to note that none of the academic degree programs are impacted and every student has the possibility of earning a degree in four years. USK surveys indicate that over 95% of graduates are in graduate/professional studies or employed within six months of graduation.

#### **Diversity:**

The United States Department of Education has designated USK as a Hispanic Serving Institution. Approximately 38% of USK students are of Hispanic descent and over 50% of the student body is persons of color with approximately 30% of the students being first generation college attendees.

#### Financial Aid:

Tuition for USK was \$23,500 dollars for the 2018-2019 academic year. Several sources of financial aid are available, particularly to students of demonstrated financial need. USK has its own grant program (\$8,225) and was recently approved for the Federal Pell Grant Program (\$5,920), the Cal Grant (\$9,223), and the Federal Work Study (\$2,400). Consequently, a total of up to \$25,756 is available for tuition coverage. Additionally, GI Bill and other Veterans' Affairs grants are also available. Further financial support is available through low-interest Federal Title IV loan programs.

#### Faculty:

The Faculty report to the Dean and Chief Academic Officer (Gilbert, PhD Victoria) through departmental chairs including Arts and Humanities (Getz, PhD Baylor), Business (Boukouzis, MBA Chicago), Kinesiology (Rodriguez, PhD/ABD, Concordia), and Natural Sciences (Grkovich, PhD, UCSD). USK employs approximately 20 adjunct faculty per year and offers 60-70 courses per semester. Approximately 80-85% of all faculty hold the highest degree awarded in their field and the student to faculty ratio is approximately 9:1. A more complete list of the faculty is included in Exhibit "A".

#### **Board of Trustees:**

The USK Board of Trustees includes 12 members that represent banking, business, education, legal and philanthropic experience. The University does not receive financial support from any church organization or hierarchy, and no Board members are clergy or employed by the church.

#### Conclusion:

USK institution's academic record and rigor of its programs is impressive for such a new institution and this is supported by their WASCUC accreditation and articulation agreements with other institutions. In addition, the graduation rates, affordability level for a private non-

profit education, low student-to-teacher ratio, no impacted programs and various options for financial aid to assist students complete their education are also notable. Based on our findings we would recommend extending the ENA by an additional 90 days so we can review their financial ability to build, maintain and operate a new facility on the University and Innovation District property.

#### **ARTS AND HUMANITIES**

#### Robert Fortuin, Assistant Professor of Orthodox Christian Theology\*

Robert Fortuin holds an MLitt Degree in Divinity from St Mary's College, University of St Andrews, Scotland. His work there was on the rhetorical theology of early Christian apologist Clement of Alexandria. Professor Fortuin's research interests include philosophical theology, patristics, and systematic theology. He is presently doing PhD level research on Gregory of Nyssa's theology of 'Division of Being' at King's College, University of Aberdeen, Scotland. Professor Fortuin has been a Faculty Member at University of Saint Katherine College since 2014, teaching courses in New Testament, Orthodox Theology, and the Ecumenical Councils.

## Gaelan Gilbert, Associate Professor of English Language & Literature, Chair of Arts & Humanities Department

Professor Gaelan Gilbert received his PhD in English from the University of Victoria, his MA in English from San Diego State University, and his BA (double major in English Education and Philosophy/Theology) at Point Loma Nazarene University. His research interests dovetail at the intersections of literature, theology, history, education, and artistic culture in ancient, medieval and modern contexts. He has recently published a chapter on St. Augustine's rhetorical personification of nature in *Confessions*, and an article on alternative models of liberal arts higher education. He is the Program Director for the Integrated Core Curriculum at USK, the In-House Editor for the Saint Katherine Review, and the lead coordinator and faculty for the Study Abroad Greece summer program.

#### Megan Gilbert, Assistant Professor of Fine Arts\*

Professor Megan Gilbert received her B.A. in Art Education from Point Loma Nazarene University in San Diego. In addition to USK, she has taught at the Vancouver Island School of Art in Victoria, BC. She has exhibited work in the U.S., France, Germany, Greece, and Canada, in the media of photography, illustration, drawing, painting, installation, and printmaking. She has two children's books published through Ancient Faith Publications: A Child's Guide to the Divine Liturgy, and When God Made You. She teaches photography, 2D Design, and classical Greek art history at USK.

#### Fr. Josiah Trenham, Professor of Orthodox Christian Theology

A native Southern Californian, Father Josiah attended Westminster Seminary California, receiving his M.Div. in 1992 while studying under some of the most influential teachers in the Reformed tradition. In 1993, he was ordained to the Holy Priesthood of the Orthodox Church and in 2004 he was awarded a Ph.D. in Theology from the University of Durham, England. Father Josiah has served as pastor of St. Andrew Orthodox Church in Riverside, California, since 1998. Father Josiah has published numerous articles and two books and is also the founder of Patristic Nectar Publications, a non-profit ministry.

#### Breann Williams, Assistant Professor of History\*

In addition to being an adjunct faculty member in the Arts & Humanities Department, Professor Bre Williams currently serves as Dean of Students and the Title IX Coordinator at the University of Saint Katherine. With a passion for history and teaching, her main areas of interest are colonial America and the history of the Middle East, specifically in Israeli-Palestinian conflict. She holds an M.A in Education with an emphasis in teaching.

#### Dcn. David-John Williams, Assistant Professor of History\*

Professor David-John Williams received his MA from Royal Holloway, University of London. His research areas include Byzantine relations with the West from 600-1453; Greek Palaeography and Shared Sacred Space. His MA dissertation investigated the contribution of the canons of the Quinisext Council (629) to anti-heretical literature and the schism between the Byzantine and Latin Churches. Recent publications include: "Did The Crusades Change the Byzantine Perception of Holy War?" in Porphyra, "Mediterranean Religion", Duke University and "Christian Saints as allies of non Christians". His PhD thesis is entitled Shared Sacred Spaces: Saints, Relics and Sacred Objects in the Byzantine Mediterranean.

#### Nazo Zakkak, Assistant Professor of Music

Professor Nazo Zakkak received his BM in Jazz Studies from San Diego State University and his MFA in Integrated Composition Improvisation and Technology from UC Irvine. As a performing pianist he has notable experience within the fields of Jazz and Experimental Music. In 2012, he turned his attention towards the sacred music of the Orthodox Christian Church and has since composed music for churches and monasteries across the U.S. His works have been recorded by various choirs, and in 2017 he released an album of original new Orthodox hymns, *Luxari*. His has recently been commissioned to compose 3 Divine Liturgies which will see their completion by the end of 2018. Nazo Zakkak works as Composer-in-Residence for the Antiochian Archdiocese of North America and as Choir Director at St. Anthony the Great Antiochian Orthodox Church in San Diego.

## Christos Korgan, Assistant Professor and Director of Institutional Research and Effectiveness

She began teaching at University of Saint Katherine in January 2017.

He has extensive international experience as a retail banker and military leader who specializes in organization management and strategy. Professor Smith is currently an executive consultant with Lee Hecht Harrison – the largest career transition firm globally. He is a twenty-three-year veteran of the US Army (Finance Corps), having served in two wars and achieving the rank of Lieutenant Colonel.

#### Alyssa Ramos

Alyssa is a Teaching Assistant at USK. She is excited to join the USK staff after completing her undergraduate education at Southeastern University in Lakeland, Florida. Throughout her time at Southeastern she received her Bachelors in Legal Studies and her Masters in Business Administration with an emphasis in Executive Leadership. Throughout her Master's coursework she had the opportunity to work as a Graduate Assistant under the department chair for the College of Business as well as be a member and captain of the women's basketball team. # Jessica Rodriguez, Assistant Professor of Kinesiology and Chair of the Kinesiology Department

Originally from Louisiana, Professor Jessica Rodriguez moved to California in 2008 and completed a dual MS in Exercise Physiology and Nutritional Science at San Diego State in 2014. At SDSU she was able to increase her skills in exercise and nutrition research ranging from assisting on studies investigating the effects of carbohydrate rich foods on glucose regulation,

serum lipids, blood pressure, and adiposity in prediabetes and metabolic syndrome, to evaluating the effects of amino acid supplementation on swimming performance in elite and recreational swimmers. Jessica began lecturing at USK in Spring of 2016 and is excited to be a part of the faculty at a growing and thriving institution. She is currently the Chair of the Kinesiology Department at USK.

#### Josh Dexheimer, Assistant Professor of Kinesiology\*

Professor Joshua Dexheimer holds a B.A. in Exercise Science from Point Loma Nazarene University, an M.S. in Biokinesiology from the University of Southern California, and is a PhD candidate receiving his degree from Concordia University Chicago in Health and Human Performance. Dexheimer also holds several certifications as a Strength and Conditioning Specialist, USA Weightlifting Sports Performance Coach, and Performance Enhancement Specialist. He also instructs at Point Loma Nazarene University where he is the Program Director for their NSCA recognized Strength and Conditioning Program. He serves as a strength and conditioning consultant and owns a health and wellness company called MetanoiaFit. His home church is The Rock Church where he serves with the Youth Group. He resides in Pacific Beach with his wife Lauren, who is a nurse at UCSD.

#### Josh Koeplin-Day, Assistant Professor of Kinesiology\*

Professor Joshua James Koeplin-Day is a certified athletic trainer and adjunct professor in Athletic Training at University of Saint Katherine. He earned his MA in Rehabilitation Science at SDSU, having completed his undergraduate work at SDSU in Kinesiology with an emphasis in Athletic Training. In the summer of 2012, he was certified by the Board of Certification (BOC) and has been working since then as an Athletic Trainer in the San Diego area, especially at the X-games and with many division 1 athletes at SDSU and USD.

#### Nick Szyndlar, Assistant Professor of Kinesiology\*

Professor Nick Szyndlar received a Master's degree in Exercise Science and Nutrition from Sacred Heart University with an emphasis on Performance. He is a certified Strength and Conditioning Specialist as well as United States Weightlifting Association Sports Performance Coach. He is also a former Division I College Tennis Coach at Sacred Heart University 2016 and Fairfield University 2017. His research interests include the benefits and risks of supplementation, especially with caffeine.

#### **NATURAL SCIENCES**

#### Geoff Bray, Assistant Professor of Chemistry Chair of the Natural Sciences Department

Professor Geoff Bray is a multi-faceted scientist with a primary scientific interest sensory neuron pathologies. He completed his graduate work at the University of Saskatchewan in Canada, where he hails from originally. Past research experience has been in both plants and fungi. Currently, his main focus is on the study of liberal arts and science teaching pedagogy in order to deliver the best possible curriculum to the unique needs of the students at USK. He has been an assistant professor and chair of the department for the past 4 years. During the 2016-17 academic year, he was awarded Professor of the Year for excellence in teaching. During his tenure he has helped shape the department to include a wide variety of instructors who bring outside research and experience into the classroom, giving students a unique perspective into what a scientific career will be like upon graduation. He is bilingual (English and Spanish), and loves fishing, hockey, and rock climbing.

## Kaitlin Fisher, Assistant Professor of Natural Sciences, Chair of the Natural Sciences Department (Chemistry & Biochemistry)

Professor Kaitlin Fisher is a specialist in biophysics – in particular the investigation of protein folding and dynamics and their applications to novel drug design. She received her Ph.D. from the University of California, San Diego where she specialized in NMR, protein kinetics, and computational modeling in 2015. She received her B.S. in Chemistry at Sonoma State University in 2009 where she was awarded the Howell Fellowship for original research. She has a tremendous passion for teaching, research, and scientific outreach. In her off time she is usually somewhere outside running or hiking with her husband and dog, Carl.

#### Andrej Grkovich, Assistant Professor of Natural Sciences\* (Chemistry & Biochemistry)

Dr. Grkovich is a multidisciplinary scientist with educational background in biochemistry, molecular biology and general chemistry. During his post-graduate studies, he investigated the regulation of membrane-associated pro-inflammatory proteins via the activation of inflammatory signaling and lipid second messengers through the use of a macrophage cellular model. During his course of industrial experience as an assay developer, he designed and developed in vitro point-of-care diagnostics that have been vetted through clinical trials for purpose of market sale. He has had the opportunity to provide mentorship and teaching to students in the academic setting, and technicians and junior scientists in the professional environment.

#### Michael Reedy, Assistant Professor of Natural Sciences\* (Mathematics)

Professor Michael Reedy received a Master's degree and ABD from the University of New York at Binghamton where he studied mathematics in general with an emphasis in topology. He has taught at most of the colleges and universities in the greater San Diego area, as well as for the department of defense. His current research interest is in the epistemology of mathematics education. He is a father of two, and an avid musician. He is teaching Algebra and Calculus at the University of St. Katherine.

#### Natalia Volodina, Assistant Professor of Natural Sciences\* (Biological Sciences)

Professor Natalia Volodina is a molecular biologist with an undergraduate training in Biology/Genetics from St Petersburg State University and a Ph.D. in Molecular Biology, Cell Biology and Biochemistry from Brown University. She has done postdoctoral research in Boston as well as in France in the area of neurodegenerative diseases, and has about 10 years of teaching experience at the higher education level. She moved to the San Diego area 2 years ago and has been teaching Cell Biology at the University of San Diego. She enjoys travelling and learning foreign languages, and is trilingual (Russian-English-French with some Spanish).
