NOTICE OF PUBLIC HEARING

THE CITY'S SOLID WASTE AND RECYCLING SERVICES

The City Council will hold a public hearing to consider the proposed rate increases on September 24, 2019, at 5 p.m. The public hearing will be held in the City of Chula Vista Council Chambers located at 276 Fourth Avenue Chula Vista.

At the public hearing, the City Council will consider the proposed rate increases, public testimony, and written protests. A written protest must contain all of the following information:

- 1. The name and signature of the property owner, or Republic Services customer, of record who is submitting the protest;
- 2. The street address or Assessor's Parcel Number (APN) that the protest concerns; and
- 3. A statement that the property owner or customer submitting the protest opposes the proposed rate increase.
- 4. Be received prior to the conclusion of the public hearing.

All written protests must be received prior to the conclusion of the public hearing and may be mailed or delivered in-person to:

Please note the following:

- Protests that are mailed to the Chula Vista City Clerk must be received by 4 p.m. on September 24, 2019 regardless of the date mailed or the date of postmark.
- Written protests will also be accepted in the City of Chula Vista Council Chambers during the public hearing.
- No more than one written protest per parcel of property will be counted in calculating whether a majority protest exists.
- Any protest submitted via fax, email or other electronic means will not be accepted.
- Oral comments at the public hearing will not qualify as a formal protest, unless accompanied by a written protest.

Frequently Asked Questions:

Why did I get this mailing?

This mailing serves as notice on the proposed increase in solid waste and recycling collection service rates.

Do I have to respond to this?

No, you do not have to respond to this notice. If, however, you oppose the fee increase or the adjustment formulas, you can file your written protest with the City Clerk's Office as described above.



The City's Solid Waste and Recycling Services

Residents and businesses in the City of Chula Vista receive solid waste and recycling collection services from the City's franchised waste hauler, Republic Services ("Republic"). The contract between the City and Republic establishes maximum rates Republic may charge its customers and allows for periodic increases to those rates. In accordance with the contract, Republic has requested an increase in the rates it charges for solid waste and recycling collection services.

The Proposed Rates

General Service Rate Increases

Republic has requested the rate increase to cover increased costs for providing the collection services. The increased costs are due, in part, to recent global disruptions in the recycling industry which have created a slowdown in recycling markets, greatly increasing processing costs and decreasing recyclable material values. Because of increased costs to provide the services, Republic has requested a rate increase of 7.6% on current general service rates. If approved, the rate increase will go into effect on October 1, 2019, using the following formula:

$.076 \times \$21.78 = \1.65 , making the new rate \$21.78 + 1.65 = \$23.44

Listed below are the current rates and how they are affected by the proposed rate increase for common levels of service.

Consumer Price Index Rate Adjustments

In addition to the above, the contract with Republic provides for annual inflationary increases based on the Consumer Price Index (CPI). If the rate increase is approved, rates will be adjusted each year for the past five years as follows:

adjusted each year for the next five years as follows:

• Large Quantity Generators ("LQG") (commercial – bin service) rates are adjusted every July 1, starting in 2020. The annual adjustment for LQGs will be equal to the San Diego Area CPI for all Urban Consumers, as published by the U.S. Department of Labor, Bureau of Labor Statistics for the previous 12-month calendar year period. The following formula will be used to determine the annual LQG rate adjustment:

CPI% x Service Rate = LQG General Service Rate Increase
Example: If the applicable CPI is 3.4% (actual CPI will vary from year-to-year), a LQG rate of \$119.71 would be adjusted as follows:
1.034 X \$119.71 = \$123.78 (before all governmental fees)

• Small Quantity Generators ("SQG") (residential – cart service) rates are adjusted every September 1, starting in 2020. The annual adjustment amount for SQGs will be the same as the adjustment for the LQGs, with the following exception: at no time shall residential ratepayer rates exceed 90% of the average for the County of San Diego for the same level of service, after subtracting any governmental pass-thru fee. This limitation is applied only to determine whether Republic is entitled to the full adjustment or prorated amount on Small Quantity Generators.

CPI% X Service Rate = SQG General Service Rate Increase
Example: If the applicable CPI is 3.1% CPI (actual CPI will vary from year-to-year), a SQG rate of \$16.49 would be adjusted as follows:
1.034 X \$16.49 = \$17.00* (before all governmental fees)
*As long the rate is at least 10% below the County average.
