SUMMARY

On September 10, 2019, City Council approved Resolution No 2019-177 amending the compensation schedule and classification plan to reflect the addition and deletion of various position titles and amending the authorized position counts in various department with a net increase in authorized staffing. After approval, staff discovered that while the accompanying Agenda Statement and all other resolutions were correct, Resolution No. 2019-177 inadvertently omitted two position titles (four FTE). Staff is requesting adoption of a resolution that includes the omitted position titles.

ENVIRONMENTAL REVIEW
